Letter of Permission for admission of students to the B.V.Sc &A.H. Course at M.B. Veterinary College, Dungarpur, Rajasthan affiliated under Rajasthan University of Veterinary and Animal Sciences, Bikaner, Rajasthan.

Sir,

I am directed to refer to the applicant M.B. Health and Hygiene Nursing Shikshan Sasthan and MB Veterinary College, Dungarpur letter No. MB Vet /DPR/2017/1666 dated 12.06.2017 on the subject mentioned above and to say that the proposal of admission for First Year B.V.Sc. & AH. Course at MB Veterinary College, Dungarpur under Rajasthan University of Veterinary and Animal Sciences, Bikaner, Rajasthan was submitted to the Central Government as per Veterinary Council of India (procedure for recognition and derecognition of Veterinary College and Veterinary Qualifications) Rule, 2017.

The Proposal of the College was considered in the Advisory Committee constituted under rule 16 of the said rule. The Advisory Committee deputed inspection team during 07.01.2019 to 09.01.2019 and 02/09/2019 to 04/09/2019. Based on the Inspection Report the Advisory Committee in its meeting dated 13.09.2019 recommended inter alia:

"The Advisory Committee considered the report of the inspection held on 2-4 September 2019 for assessing the facilities and manpower and compliance of the deficiencies observed by the Advisory Committee in its meeting dated 14.03.2019 for permission for Admission in First Year B.V.Sc. & AH Course at M.B. Veterinary College, Dungarpur. Based on the report of the inspection committee the advisory committee recommends for the start of B.V.Sc. & AH programme from the academic year 2019-20 with a maximum intake of 80 students."

The Recommendation of the Advisory Committee has been accepted by the Competent Authority and the Central Government has decided to allow admission in the First and Second Year B.V.Sc. & AH. Course upto 80 Admissions for the academic year 2019-20 and 2020-21 respectively as per rule 8 of VCI Rule 2017.

The grant of letter of permission shall be subject to the applicant furnishing a Bank guarantee for an Amount of Rs. 5, 00, 00,000/- (Ruppees Five Crore Only) in favour of Cont......

Veterinary Council of India from a Scheduled Bank situated in Delhi, which shall initially be valid for a period of Five Years and thereafter, the said Bank guarantee shall be extended from year to year by the applicant and shall at no point of time be allowed to lapse and adequate documentary proof of having creating a fixed deposit for a minimum duration of two years with a Scheduled Bank equal to the amount of estimated annual salaries, payable to the faculty to be employed by the Veterinary College during it second academic year within one month of issue of letter of permission.

The University is requested to kindly ensure strict compliance, in its affiliated M.B. Veterinary College, Dungarpur, Rajasthan, by the contents of this communication.
